



Zoonotic Disease Report May 28 – June 03, 2017 (Week 22)

Executive Summary

- Statewide 59 specimens have tested positive for rabies in 2017 including two domestic dogs in Yuma and Weld Counties. This compares with 88 total positive specimens in 2016.
- 2017 Colorado rabies positive specimens: Skunk (46), Bat (8), Dog (2), Fox (2), Coyote (1)
- In Boulder County one bat and one skunk have tested positive for rabies.
- One cat in Longmont tested positive for plague in May.
- Larval mosquito control and adult surveillance has begun.
- Testing of mosquitoes for West Nile virus will begin June 12th.
- One bat was tested for rabies this week, testing negative.
- No specimens were submitted for plague, tularemia, or hantavirus testing this week.

Zoonotic Disease Report September 03 – September 09, 2017 (Week 36)

Executive Summary

- The first Colorado WNV death was reported this week from a resident in Ft. Collins.
- Boulder County reports one new human WNV cases bringing the total to three cases this season.
- CDPHE reports 21 WNV cases from 11 counties.
- CDC reports 526 WNV cases and 20 deaths nationally from 37 states.
- Texas is now dealing with a surge of mosquitoes as a result of flooding from Hurricane Harvey.
- Two bats were tested for rabies this week, both testing negative. One raccoon was submitted for rabies testing and deemed untestable.
- Statewide 123 specimens have tested positive for rabies in 2017 including two domestic dogs. This compares with 88 total positive specimens in 2016.
- Colorado rabies positive specimens 2017: Skunk (64), Bat (51), Dog (2), Fox (5), Coyote (1).
- No specimens were submitted for plague, tularemia, or hantavirus testing.







Zoonotic Disease Report September 10 – September 16, 2017 (Week 37)

Executive Summary

- Boulder County reports one new human WNV case bringing the total to four cases this season.
- CDPHE reports 25 WNV cases and one death from 12 counties.
- CDC reports 740 WNV cases and 34 deaths nationally from 38 states.
- National, state, and local cases will increase as cases are identified through the fall.
- Both total mosquito and *Culex* species counts were above average for this season although fewer pools tested positive for WNV than in 2016.
- One bat was submitted for rabies testing this week, results are pending.
- Ninety two specimens have been submitted for rabies testing with six testing positive: Bat (5), Skunk (1). Multiple specimens were deemed untestable.
- Statewide 124 specimens have tested positive for rabies in 2017 including two domestic dogs. This compares with 88 total positive specimens in 2016.
- Colorado rabies positive specimens 2017: Skunk (64), Bat (52), Dog (2), Fox (5), Coyote (1).
- No specimens were submitted for plague, tularemia, or hantavirus testing this week.
- Seven specimens have been submitted for plague with one cat testing positive this year.
- Five specimens have been submitted for tularemia with none testing positive.
- No specimens have been submitted for hantavirus testing.
- Additional specimens may be submitted for testing through the remainder of the year.



