ADDITIONAL SCORING CRITERIA

Small Communities	Prioritize projects in small communities so they can compete
Regional Connections	Prioritize projects that help the most people, traveling longer distances, connecting multiple communities
Multimodal	Prioritize transit, bike, ped and TDM projects. Prioritize projects that shift trips to non-SOV to achieve our goals
Safety	Prioritize projects that reduce severe and fatal crashes
Technology	Prioritize a countywide study that helps prepare Boulder County local agencies for the AV/EV/Mobility as a Service revolution!

ADDITIONAL SCORING CRITERIA

QUESTION: Should we limit the number of applications one agency can submit?

- Total project request should be double the available funding
- All projects will have to be scored by all agencies
