Land through the Lens – A 2019 Photography Exhibit featuring Boulder County Parks and Open Space Land Rules and Guidelines

To be eligible to apply photographers must:

- Submit only photographs of Boulder County Parks and Open Space land. Click here for a link to a map of Boulder County Parks and Open Space land and for a list of recommended areas: www.BoulderCountyOpenSpace.org/photoshow.
- Submit up to 5 photograph in jpg format, the name of the property where the photo was taken, and \$30 by June 19, 2019 through the website: www.BoulderCountyOpenSpace.org/photoshow. Each image should be no larger than 10 MB in size and should be at least 1920 pixels in width or 1080 pixels in height. Please crop images to exclude signatures, framing and matting.
- Previously published images are allowed except for those chosen for previous Land through the Lens exhibits.
- Agree that any number of up to 5 submissions will be chosen, from 0 – 5, to be exhibited. A panel of judges will review submitted digital images and make a final decision on exhibiting photographers. Applicants will be notified of acceptance by Tuesday, July 9.
- Adhere to Boulder County Parks and Open Space Rules and Regulations; visit the website <http://www.bouldercounty.org/play/recreation/pages/posrulesandregs.aspx>.
- Abide by Colorado law with respect to invasion of privacy and defamation of photographing members of the public.
- Not infringe on the rights of any other photographer or person or submit images that involve the willful harassment of wildlife or damage to the environment by the photographer.
- Agree that failure to comply with all the exhibit provisions will lead to the disqualification of your entry.
- Agree that Boulder County reserves the right to refrain from exhibiting a photograph for any reason.

- Agree that entrant's digital images may be used for publicity for the event. Entrants will retain all rights to their artwork although Boulder County reserves the right to post images of all entries on its website, through social media outlets such as Facebook and Twitter, press releases, and/or other promotional materials for this event. Boulder County shall not reproduce any artwork for sale or commercial use without a prior written agreement of the artist.

Boulder County is not responsible for applications that are incomplete, lost or not received and is not responsible for any problems or technical malfunction or human error in the application process. Although Boulder County attempts to ensure the integrity of the application process, Boulder County is not responsible for the actions of applicants in connection with the application process, including applicant's attempts to circumvent these rules.

Photographers selected must agree:

- To exhibit selected works at the Great Frame Up - Longmont, Colorado from Friday, August 9 through Friday, Sept. 6, 2019.
- To bring work to The Great Frame Up Longmont on Monday, August 5 or Tuesday, August 6 between 10 a.m. and 4 p.m.
- To make their artwork available for sale on consignment with the Great Frame Up. The Great Frame Up will take a 35% commission on the sale price of all pieces sold at the show. The Great Frame Up will handle all transactions for the artists and collect and submit the required sales taxes.
- That work submitted for the exhibit must be properly framed including a wire (no saw-tooth Hangers, cleats, screws, or exposed glass edges). "Gallery Wrapped" and "plaqued" photographs may be displayed unframed, without glass, but must have finished edges, as well as a wire for hanging. Photographs printed on metal are allowed without frames and can be hung using the built-in hanger on the back. Boulder County is not responsible for breakage or replacement if work is framed under glass. Any photograph not properly framed will not be accepted in the show, but the photographer will be given the opportunity to re-frame.
- That if the quality of the photograph which was submitted for consideration for exhibit is judged to be not of equivalent quality to electronic submissions, the photograph may not be exhibited.
- Wall art must not exceed 35 pounds in weight.
- That work which is not sold will be collected on Saturday, September 7 or Monday, September 9 between 10 a.m. and 4 p.m.
