Waiver/Alternative Requirements Authority Applicable to FY 2019 Indian Community Development Block Grant (ICDBG) Funds and Removal of Public Services Cap.

Notice PIH 2020–05 identified waivers and alternative requirements applicable to the ICDBG Program. Throughout the Notice, HUD stated that the waivers and alternative requirements were applicable only to ICDBG-CARES funding and FY 2020 ICDBG grants. After further review, the Department wishes to clarify that such authority is not limited to FY 2020 ICDBG funds but also applies to FY 2019 ICDBG funds. This is because Congress included authority to waive or specific alternative requirements in the Community Development Fund account in the CARES Act. This authority applies to funding previously provided under the Community Development Fund account in Public Law 116-6. Because FY 2019 ICDBG funding was provided under this account in Public Law 116-6, HUD does have the authority to apply waivers and alternative requirements to FY 2019 ICDBG funding, in addition to FY 2020 ICDBG funding and ICDBG-CARES grant funding. The same applies to the removal of the public services 15 percent cap with respect to FY 2019 funding used to prevent, prepare for, and respond to COVID-19. With this correction, HUD is allowing the waiver flexibilities specified in Notice PIH 2020–05 to apply to FY 2019 ICDBG funding wherever such flexibilities also applied to FY 2020 ICDBG funding. HUD is also removing the cap on public services for FY 2019 ICDBG funding when such funding is used to prevent, prepare for, and respond to COVID-19.
