What to know about COLORADO Elections



Active registered voters are automatically sent their ballot in the mail.

Voters can then either return their mail ballot (by secure 24-hour drop box or mail) or vote in-person.

If voting in-person, voters may visit any Vote Center in their county to vote. ID required.

Colorado does not have a registration deadline. Eligible voters can register to vote up to and including Election Day.



VOTE READY CHECKLIST

- Registered/checked my voter registration at www.GoVoteColorado.gov
- Added my email address to my voter registration record online so my Elections office can stay in touch (optional, but recommended; email addresses are considered private)
- Signed up to track the status of my ballot with Ballot Track (visit www.BoulderCountyVotes.org)
- Reviewed what will be on the ballot (available on our website after Sept 15)
- Received my ballot the week of Oct 12
- Filled my ballot out and signed my ballot envelope
- VOTED!!! 😊 (returned my ballot to a 24-hour drop box by 7 p.m. on Election Day or mailed it by Oct 26)

KEY ELECTION DATES

- SEPTEMBER 22** National Voter Registration Day
Check your registration today!
See inside for details.
- OCTOBER 9** Ballots mailed to voters.
- OCTOBER 19** Vote Centers begin opening for in-person services or order a Ballot-to-Go!
- OCTOBER 24** National Vote Early Day!
- OCTOBER 26** Last day to register to vote and still be mailed a ballot. After this date, you can still register / vote in-person or get your Ballot-to-Go.
- OCTOBER 26** Last recommended day to return your ballot by mail (or simply use a 24-hour drop box by Election Day).
- NOVEMBER 3** Election Day!
