Why Transportation Options are Key to Successful Vaccination

Vaccinating Boulder County residents is an enormous undertaking that requires collaboration and cooperation across multiple county departments and human service providers. Mobility for All as Boulder County's mobility management specialists are responsible for ensuring that all county residents have access to reliable and affordable transportation. This need has only been heightened over the course of the COVID-19 pandemic. In order to effectively and efficiently vaccinate Boulder County residents, Mobility for All has created a transportation resource matrix. The above matrix tracks key information for each transportation provider in the county who is offering trips to vaccination sites. The information contained in the matrix includes, agency, population served, services provided, contact information, costs and what precautions each organization is taking to keep drivers and passengers safe. This plan will serve as a resource to match clients with transportation to get there to and from their COVID-19 vaccination appointments.

Mobility for All recognizes that there is no one sized fits all transportation solution for all people. Transportation is tied to many other aspects of a person's life; this makes it a challenge to simply recommend one transportation solution to get clients to a vaccination site. Boulder County is fortunate to be served by multiple transportation providers all of whom have adjusted their services and made vaccine trips a top priority. Because of the volume of trips that are needed, the public and human service providers cannot simply rely on one transportation provider to meet all vaccine trip needs. This plan provides an easily accessible way to view and determine what transportation options meet a client's needs. Transportation access is key to successful getting residents to vaccine site and mobility management, through leveraging relationships and bridging the gap between human services and transit providers plays a key role in the county's success. Funding Transportation to Vaccine Sites

Transportation to a vaccine site, especially for those who do not drive or do not have regular access to a car is key to getting vulnerable groups vaccinated. While transportation is key, it can be finically prohibitive for many individuals. The above transportation resource inventory includes traditional transportation, such as RTD, Via and ZTrip Taxi services, as well as informal transportation providers, such as gas cards for individuals to drive to themselves or others to vaccine sites. Both types of transportation options are needed because not all financial barriers are the same, some people may face a barrier in paying for the bus where others may need help covering gas for their car. While these struggles are not the same the end result is the same, an inability to reach a vaccine site. In order to help overcome some of these financial challenges it is important, when possible, that local governments and organizations cover some or all of transportation costs to vaccine sites when possible.

Distribution of the Transportation Plan action Steps

This transportation plan will be distributed using multiple methods to ensure that it reaches as many organizations and people as possible. The outreach and distribution can be split into two broad categories, Mobility for All outreach resources and Boulder County Public Health outreach resources.

Mobility for All

Mobility for All will promote and distribute this plan in multiple methods:

- 1. The plan will be included in both Mobility for All's monthly newsletter and the Mobility for All Local Coordinating Council newsletter
- 2. The plan will be distributed to all members of the Local Coordinating Council, which includes both transportation and human service providers
- 3. Mobility for All will share the plan with Peak to Peak Housing and Human Service Alliance and HHS Local Area Collaboratives
- 4. Mobility for All will share bilingual posts to their social media channels promoting and directing people to the plan
- 5. Mobility for All will create a partner social media toolkit with bilingual content to share with community stakeholders

Boulder County Public Health

Boulder County Public Health will promote and distribute this plan multiple methods:

- 1. The plan will post this plan to the <u>COVID-19 Vaccines</u> page on the counties website.
- 2. The plan and partner social media toolkit will be distributed to Boulder County and Municipal Communications Specialists
